However, it should be noted that the changes described in this MCCP are to ensure that the intent of the Approved Changes that are pertinent to the March 2017 Release are fully reflected in the Market Code and CSDs.</p>

**A.2.d. DRAFT LEGAL TEXT**  
Required under Market Code Parts 8.7.1 (ii) (d) and 8.8.1 (ii) (d)

The purpose of this MCCP is to consolidate those changes being made to the Market Code and Code Subsidiary Documents as a consequence of the March 2017 Release. In particular, including refinements which have not already been captured in MCCPs.

The additional changes are:

- **CSD0205** – The CSD has been further updated to be consistent with similar wording in CSD0207, such that, in Section 2.2.2, references to ‘...periods after 2017-04-01’ have been changed to ‘...periods on or after 2017-04-01’.
- **CSD0207** – The CSD has been further updated to;
  - Correct wording in Section 2.3.19; the description for ‘R2’ should be ‘the corresponding read’ and not a duplicate of the previous description. Corrections to the definition of VAC have also been incorporated, to reflect the intent of MCCP207 – CC.
  - Remove a defunct reference to SEs for sewerage services to caravans (Section 3.4.11)
- **CSD0301**– The CSD has been further updated to reflect:
  - A typo, whereby a reference to the T035.0 has been identified wrongly as T035.1. This has been corrected.
  - New or modified error codes, as follows;

Error Code	Revised Text
BA	MID should only contain numeric values after the Org ID

<b>BD</b>	Transaction rejected as MID number falls into a range that has been archived. Resend message with a new MID.
<b>DG</b>	MIDs submitted to the HVI are not allowed within the LVI MID range (1000000000 to 1999999999). Resend message with a new MID.)
<b>DX</b>	SS SPID is paired with a WS SPID with a status of Tradable or TDISC.
<b>JW</b>	I and F reads for Pseudo Meters must be zero.
<b>KQ</b>	Rateable Values must be whole numbers or allowed default values.

- **CSD0301 Annex** – The Annex contains raw XML from the CMA CS code. This is generated directly from the code once the new version of the code is accepted by the CMA.
- **CSD0302** – This CSD has been further updated to reflect that the following items were not actually part of the data download from the CMA CS to the SLP, being unnecessary for SLP functionality:
  - D2038 – SAA Reference Number Absence Code
  - D2040 – UPRN Absence Code
