A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

Form H is used by Licensed Providers to submit applications for Trade Effluent on behalf of their customers. The form is detailed in the Appendix to the Operational Code and is submitted to SW electronically via the Customer Portal. The form is used for all types of Trade Effluent application (New Consent, Consent Review, etc) with the LP selecting the type of application by ticking the appropriate box.

There have been instances of LPs not selecting the correct application type on the Customer Portal which necessitates re submission. The proposed changes are intended to make the application submission process more transparent thereby reducing errors and minimising any delay in processing the customer's request.

A.2.b. DESCRIPTION OF THE NATURE AND PURPOSE OF THE MCCP / OCCP AND HOW IT MEETS THE MARKET CODE / OPERATIONAL CODE OBJECTIVES AND PRINCIPLES FOR THE MARKET DOCUMENTS Required under Market Code Parts 8.7.1 (ii) (c) and 8.8.1 (ii) (c)

General Description

The purpose of the changes is to provide clarity to market participants and in order to do this SW seeks approval for the following:-

- 1. Changes to Form H to ensure that the text describing the type of Trade Effluent application is aligned to that of the Customer Portal submission form.
- 2. Addition of Discharge Point ID (DPID) to be quoted for all applications other than New TE Consent. This is to clarify to which DPID the application relates should there be more than one DPID at a SPID.
- 3. Removal of the option to request a Temporary Consent. SW determines whether or not a Temporary Consent is appropriate based on all the information provided in the application. There have been occasions when SW has determined that a full Consent was required even when the applicant had selected Temporary Consent which can lead to confusion for the applicant and the LP.
- 4. The addition of explanatory text to make it clear that Discontinuations are temporary and Terminations are permanent. There have been situations when applicants have selected Discontinuation when in fact a Termination was required.

The LPs have been consulted regarding the proposed changes and no comments have been received.
